Description of Facility	The proposed facility applies custom graphics to garments using direct-to-garment printing equipment.	
Source Designation	<u>Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for installation of garment printing and drying operations at the above described facility. The application has not yet been reviewed to determine if it is administratively complete.
