Affected Facility	Pacific Coast Fertilizer 3500 Hoene Ave, Longview, WA 98632	
Description of Facility	This facility is a new manufacturing plant that will process natural gas into anhydrous ammonia. Anhydrous ammonia will be stored onsite prior to shipment offsite via truck and marine vessel.	
Source Designation	<u>Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are expected to be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for installation of an anhydrous ammonia manufacturing plant at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
