Affected Facility	Glacier Northwest, Inc / All Pro Plant 1419 Bishop Road, Chehalis WA 98532	
Description of Facility	This facility operates two portable concrete batch plants with supporting material storage and handling facilities. Cement/fly ash is received at the site via truck and railcar. The cement/fly ash is used onsite or trans-shipped via truck.	
Source Designation	<u>Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for replacement of three cement/fly ash silo filters at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
